1. INTRODUCTION

The Paws & Porches Home Tour (the "Giveaway") begins at 12:00:01 AM Central Daylight Time ("CDT") on September 1, 2026, and ends at 11:59:59 PM CDT on September 30, 2026 (the "Giveaway Period").
